1. Information and scope of inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Roofing including roof space	 The roof is of pitched design, clad with concrete tiles and incorporating a tiled ridge. There are dormer window projections at both elevations with sloping concrete tiled clad roofs. There was no access gained to any accessible roof void areas due to an absence of any hatches. Sloping roofs were visually inspected with the aid of binoculars where appropriate. Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.
Rainwater fittings	The gutters and downpipes are of plastic manufacture.
	Visually inspected with the aid of binoculars where appropriate.

Main walls	The main outer walls are consistent with being of modern cavity construction comprising a structural timber frame inner leaf and roughcasted concrete block outer leaf. There are some areas of external timber cladding.
	The basecourse is of brick finish and incorporates sub floor ventilation.
	Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.

Windows, external doors and joinery	The windows are of mixed type comprising predominantly upvc double glazed units with the exception of some timber framed units. The side and rear entrance doors are of upvc composite type. There are modern Upvc, double glazed French doors off the Kitchen/Dining Room area. Internal and external doors were opened and closed where keys were available.
	Random windows were opened and closed where possible. Doors and windows were not forced open.

The front garden area is laid with grass whilst the rear garden is predominantly gravel surfaced, whilst there is also paving and a covered timber decking area adjacent to the rear elevation. The boundaries are formed in timber board fencing. To the side of the dwellinghouse, there is a loc-bloc surfaced driveway providing off road car parking space.

	Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

Floors including sub floors	The flooring is of suspended timber construction comprising chipboard sheeting laid on suspended timber joists. We would, however, emphasise that our inspection of floor surface areas was restricted due to the presence of fitted floor coverings and furnishings. There was no access gained to any sub-floor areas. Surfaces of exposed floors were visually inspected. No carpets or
	floor coverings were lifted. Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so , and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch.

Internal joinery and kitchen fittings	The internal skirtings and architraves are of varnished timber finish, whilst internal doors are of timber and timber/glazed type.
	The Kitchen units have recently been upgraded and comprise a modern range of wall mounted cabinets and worktop surfaces with integrated appliances.
	Built-in cupboards were looked into but no stored items were moved.
	Kitchen units were visually inspected excluding appliances.

Electricity	Mains supply. The electrical installation comprises 13 amp power points and the cable where visible is of pvc clad type.
	The electrical consumer unit which has recently been upgraded is within a cupboard off the ground floor Hall. The electrical meter is within a external meter box.
	Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards.

Gas	Mains supply. The gas meter is contained within an external meter box adjacent to the side entrance door.
	Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards.

Water, plumbing, bathroom fittings	Mains supply. The visible plumbing installation is in copper and plastic pipework where seen. The sanitary fittings within the ground floor Shower Room have recently been partly upgraded, comprising a WC, wash hand basin and mixer shower in-tray. The first floor Bathroom comprises a WC, wash hand basin and bath with shower over. An En-Suite has been
	formed off the Master Bedroom at first floor level comprising a modern range of units with there being a WC, wash hand basin and mixer shower in-tray. In addition a WC has been formed within a former cupboard off the second floor Landing. Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards.
	It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

Heating and hot water	Fixed central heating is provided by a gas fired `British Gas 30+` boiler
	which is within a cupboard off the ground floor Hallway. This serves a series of water filled radiators. This also provides for domestic hot water which is supplemented by an electric immersion heater and contained within a modern replacement pre-insulated "Megaflo" hot water cylinder which is within a cupboard off the first floor Landing.
	Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

	Drainage covers etc were not lifted.
	Neither drains nor drainage systems were tested.

Fire, smoke and burglar alarms	Visually inspected.
	No tests whatsoever were carried out to the system or appliances.
	New smoke alarm standards were introduced in Scotland in February
	2022 and it is likely that some properties may require additional
	works to meet these standards. In instances where alarms are in
	place, no tests whatsoever have been carried out and we cannot
	confirm if the system complies with the most recent regulations. Any
	potential purchaser should satisfy themselves as to whether the
	current system meets with regulations or otherwise.

Additional limits to inspection	At the date of inspection, the property was occupied and furnished whilst the floors were covered.
	There was no access gained to any sub-floor areas.
	There was no access gained to any roof void areas.
	It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.
	No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.
	Insulation has been laid over the roof joists and accordingly a head and shoulders inspection of the roof space was possible only.
	Not all windows and doors were tested during the course of our inspection.
	It should be appreciated that the Home Report inspection is a non- disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

	The roof was noted to be in fair order commensurate with the age and type of property although some ongoing maintenance and repairs are required.
	Concrete tiles are typically guaranteed for 30 years but according to the BRE have a reasonable life expectancy of around 50/60 years depending on exposure, weathering and damage. A roofing contractor can advise on life expectancy and likely repair/replacement costs.

4. Valuation and conveyance issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

Matters for a solicitor or licensed conveyancer

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

There has been some internal alterations carried out including the removal of an internal partition to form an open plan Kitchen/Dining Area together with the addition of the WC off the second floor Landing and an En-Suite Shower Room in a first floor Bedroom. As far as we understand, there were no permissions required for such works although full confirmation should be obtained in this regard.

Estimated reinstatement cost for insurance purposes

£365,000

The guidance figure is the estimate of costs for reinstating the subjects as at the date if inspection based on information provided by the Building Cost Information Service (BCIS). Building costs are currently increasing significantly above inflation due to increased demand and supply issues as a result of Brexit and the pandemic. It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover.

We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £365,000 (THREE HUNDRED AND SIXTY FIVE THOUSAND POUNDS STERLING).

Valuation and market comments

£320,000

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £320,000 (THREE HUNDRED AND TWENTY THOUSAND POUNDS STERLING).

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

TERMS AND CONDITIONS OF SINGLE SURVEY

GENERAL

1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. *

If the Surveyors have had a previous business relationship within the past two years with the Seller or Seller's agent or relative to the Property, they will be obliged to indicate this in the adjacent box. No

The Surveyors have a written complaints handling procedure. This is available from the offices of the Surveyors at the address stated.

1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.



The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 36 kg CO₂/m²/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. 1 Room-in-roof insulation

Insulating roof rooms will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. If it has a flat ceiling insulation can usually be added above the ceiling, and sloping ceilings and walls of roof rooms can be insulated using an internal lining board. Roof voids must have adequate ventilation to prevent dampness; seek advice about this if unsure. 2 Floor insulation (suspended floor)

Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. 3 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). 4 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent).
